**COURSE MAPS WILL BE POSTED AS PER AKC. It is recommended that exhibitors take a photo with their phone or tablet. Course maps will be emailed to exhibitors the morning of each day of the trial. If you cannot take a picture with your phone or do not have a printer at home, please see the trial secretary or someone at the scoring table.**

**Directions to show site:** **Building is right across from blue water tower.**

From South: Take I-77 or I-71 North toward Cleveland. Exit onto I-76 East toward Akron. Take I-80 toward Youngstown and NYC. Exit Bailey Road, turn right. Turn right onto Mahoning Avenue at the light.

From East or West: Take the Turnpike and Exit at Interchange 218. Take I-80 East to Bailey Road, Exit onto Bailey Road, turn right. Turn right onto Mahoning Avenue at the light.

From North: Take 11 South to I-80 West. Exit on Bailey Road, turn left. Turn right onto Mahoning Avenue at the light.

**Set up:** You may set up crating and/or tents beginning Thursday, June 20th, from 5:30-7:00PM. **First dog on the line at 9 am on Friday and 8 am on Sat. and Sun.** Building will be open an hour prior each day. Inside crating will be marked with chalk. Each dog will have about a 3' X 4' space. Mats under all crates. No dogs left onsite after show hours. You are welcome to bring a tent and crate outside or crate from your car.

Please do not leave your dogs alone uncaged in these rooms. **Failure to pick up after your dogs both at the trial and the motel will mean expulsion from the show with no refund.** Please do not permit your dog to urinate on or in the building at the motel or the show site. There are many big, grassy areas!

**Vendors and Raffles:** There will be very limited vendors inside at this trial. **Kim will be selling her awesome homemade dog treats.** **Jennifer Sharpnack PEMF Therapy & Thermal Imaging will be providing her services on Friday (possibly Saturday) PEMF (pulse electromagnetic field therapy) is \$1 per minute. Thermal Imaging can tell if your dog has any sore or inflamed areas in the body. The cost is \$10 if done in conjunction with PEMF therapy. Otherwise, it is \$20.00 if done as a stand-alone service. You can make an appointment by calling Jennifer at 330-329-2880 or schedule at the trial.**

**Show Conditions:** Indoors on rubber matting over a 5/8” foam sports cushion. Ring size is 85’ X 100’. Contacts have rubberized surface. **The site is now air conditioned** and has two very large ceiling fans and an air movement system. Electronic timers will be used. We have 8 beautiful acres to spread out for walking (or crating if you prefer outside) to the right and left of the building.

The left side has some trees, is closest to the building and has no parking lot to pass through. Right side is a big grassy area, but you must cross the stone driveway to enter the building.

**Limitations:** There will be 3 pickup bag stations available on the exterior of the building at the front and both sides for your convenience.
